COUNCIL WEEKLY UPDATE

July 21, 2022

PLANNING

Buena Vista Lagoon Joint Powers Committee (JPC) – The JPC held its regular meeting on July 18 with four of the six members present. The JPC adopted a resolution authorizing public meetings for this body to be held virtually. The JPC also received updates from both ad-hoc committees. The Enhancement Funding Ad-hoc Committee announced that they have been awarded a total of \$4 million via two grants. The Cattail Control Ad-hoc Committee discussed recent efforts for cattail removal in the wake of a recent arson fire at the Buena Vista Lagoon. The next meeting is scheduled for September 19.

ENGINEERING

Beachfront Improvements Project –The contractor continues work on minor items, including landscaping, irrigation, HVAC, lighting, electrical, and sewer lift station. The contractor is scheduled to complete work by the end of next week.

College Blvd. Widening from Barnard Dr. / Waring Rd. to Old Grove Rd. – The design work continues. The consultant met with representatives from the Rancho Del Oro HOA to discuss what landscape and irrigation improvements the HOA is maintaining. The consultant is also drafting public outreach materials.

WATER UTILITIES

PUBLIC WORKS

Oceanside Harbor – Encouraging Seaworthy/Good Appearance/Environmentally Safe Vessels - Oceanside Harbor Code requires vessels to be in good appearance, seaworthy and environmentally safe and sound. Four years ago, the Harbor had over 100 vessels in very poor condition (see photos below). In order for a vessel to be "seaworthy" it must be capable of being navigated out of the Harbor into open waters in a relatively quick timeframe. If an operator can't easily move about the deck of a vessel due to storage, tarps and other non-navigational items, then the vessel is not considered seaworthy. Another important issue for Oceanside Harbor is to protect air and water quality. When the painted fiberglass surface is not maintained by regular cleaning and occasional buffing and wax, the surface begins to oxidize, releasing volatile organic compounds into the water and air.

Harbor staff has taken a measured approach to requiring vessel owners to meet these standards. One of the ways has been to review these issues during the three-year vessel inspection, and then set-up a plan with the owner to improve the vessel's condition. Another way has been to require compliance to these issues as a condition of transferring the slip when the vessel is offered for sale. Just a few years ago, one out of every 10 vessels were in very poor appearance. Today there is less than a handful of vessels requiring improvements.
