#### **COUNCIL WEEKLY UPDATE**

February 10, 2022

#### **ENGINEERING**

**Beachfront Improvements Project Update** – Construction of the future Police substation, maintenance building, public restrooms and site work continues. The interior plumbing and electrical rough-in are under construction at the future Police substation. Structural steel roof framing and corrugated metal roofing are under construction at the public restroom. Interior wall framing, plumbing / electrical rough-ins, drywall, and HVAC duck works are under construction at the maintenance building. The main power switch gears at electrical room are in its final stage of completion. Exterior windows and operating doors are under fabrication.

**Pier View Way Bridge and Lifeguard Headquarters Project –** City and California Coastal Commission (CCC) staff held a conference call on February 8, 2022, to discuss the project site and CCC permitting requirements.

**Buccaneer Park Project –** Staff is reviewing stakeholder comments received from the January 27, 2022, public outreach meeting to help inform the final concept plan.

**Neptune Stairway Repair** – Planned work is complete. The contractor has been provided a punch list to repair minor deficiencies, including electrical work to restore lights. Upon successful lighting installation, the stairs will be fully open.

San Diego County Live Well Mobile Bus visits Oceanside Community Resource Centers - The Live Well On Wheels (WOW) mobile bus is coming to Oceanside to directly serve our community. The bus can assist residents with enrollment assistance for Medi-Cal and CalFresh, EBT card replacement, and sharing information on health insurance and access to food.

### **WATER UTILITIES**

**Urban Corps Waterways Cleanups January 2022 -** The Watershed Protection Program assisted Code Enforcement, OPD and the Homeless Outreach Team, alongside property managers at the Tri-City Crossroads shopping center in a multi-week encampment cleanup effort for a section of Buena Vista Creek. The City's contractor, Urban Corps of San Diego, performed three encampment cleanup events in January 2022 and removed approximately 10,300 lbs. of debris from City property. The property manager for the Tri-City Crossroad shopping center coordinated cleanups with their contractor from January 11 through February 1 on private property to remove debris from illegal encampments. The City and property managers will continue to coordinate and keep this site on a recurring cleanup schedule to prevent further accumulation of debris.
