COUNCIL WEEKLY UPDATE

May 26, 2022

PLANNING

Planning Commission Meeting – The Planning Commission held its regular meeting on May 23 with all Commissioners present. The following items passed unanimously:

- Regular Coastal Permit (RC21-00011) for a new single-family home at 1229 S. Pacific Street:
- Development Plan (D21-00015) for the expansion of an existing car wash at a Shell Station located at 1501 N Melrose Drive; and
- General Plan Update Phase 2, Project Alternatives. The Planning Commission recommended pursuing Alternative "B" to City Council.

ENGINEERING

Oceanside Homeless Shelter – The City Attorney has reviewed and approved the Contractor Construction Agreement and Construction Manager Agreement for San Diego Rescue Mission (SDRM); the agreements were forwarded to SDRM's Construction Manager for processing. The Construction Manager Agreement was returned completed and the City Attorney is reviewing as to form. Currently, the construction manager is finalizing the Demolition Contractor's Construction Agreement.

Beachfront Improvement Feasibility Study Phase II – A community outreach meeting for the "Option Development Phase" of the study was held on May 25 at 6:30 p.m. Attendees reviewed and commented on potential improvement options.

Buccaneer Park Project – The consultant is revising the final concept plan to reflect feedback received during the May 17 Parks and Recreation Committee meeting.

Brooks Street ADA Project – Community outreach meetings were held on May 19 and May 26 for the proposed project.

S. Strand Overlay Project – Final pavement markings and striping will be completed this week for the Measure X-funded Strand overlay project in time for Memorial Day weekend.

Butler Street Storm Drain Lining Project – The Purchase Order has been executed. The contractor has ordered project materials with an estimated start of construction in early July.

Cleveland Storm Drain – The consultant is revising the plans and specifications to send the project out to bid next month.

WATER UTILITIES

Drought Emergency Regulations adopted by State Water Resources Control Board - On May 24, 2022, the State Water Resources Control Board adopted Drought Emergency Regulations in accordance with Executive Order N-7-22. The emergency regulations require Oceanside to submit a preliminary Supply and Demand assessment on June 1, 2022; enact all Water Shortage Contingency Plan Level 2 reduction actions by June 10, 2022; and nonfunctional, ornamental turf for commercial, industrial, and institutional facilities must cease to be irrigated. The Water Utilities Department is currently assessing implementation of these

measures in accordance with the new regulation. Oceanside has sufficient water supplies to meet demands during this drought and continues to encourage the efficient use of water. Please visit www.GreenOceanside.org for updates and additional ways to save water.

May Used Oil Filter Exchange Events - The Green Oceanside team will be hosting the final Used Oil Filter Exchange Event on May 28 from 7:30 a.m. to 9:00 p.m. at the O'Reilly Auto Parts Store located at 3840 Plaza Dr. Oceanside residents can receive a free new oil filter when bringing in a used oil filter to be recycled at the participating store. In doing this we avoid pollution of our waterways and our environment, while promoting recycling.

Results of Quarterly Neighborhood Cleanup - The Green Oceanside team, Housing & Neighborhood Services, and Code Enforcement staff hosted a community cleanup event at John Landes Park on Saturday May 21. The Quarterly Neighborhood Cleanup program rotates throughout the City during the year. Seven 40-yard roll-offs of waste and three pick-up trucks full of e-waste were collected to be safely disposed of and keep our community clean. Approximately eight volunteers roamed the park and surrounding neighborhood picking up litter. The Green Oceanside team provided educational information on the City's environmental initiatives to attendees.
