COUNCIL WEEKLY UPDATE

July 7, 2022

PLANNING

General Plan Update Phase 2 – The Smart and Sustainable Corridors Plan (SSCP), a key component of the City's comprehensive General Plan Update, has been finalized and submitted to the California Department of Transportation (Caltrans) in accordance with the City's grant agreement with this state agency. With the completion of this policy guidance document, the Planning Division and its consultant partners have initiated the preparation of the Smart and Sustainable Corridors Specific Plan, which will function as the governing land use and zoning document for inland segments of the City's major east-west commercial corridors. Figure 1-2 of the SSCP illustrates the planning area for the SSCP and the Specific Plan.

Park Impact Fee Study - Staff continue to work with the consultant on the Administrative Draft of the Park Impact Fee Nexus Study, which will outline the recommended approach to calculating the proposed fee amount. The Nexus Study is anticipated to be released for public review in mid-August.

ENGINEERING

Beachfront Improvements – The restrooms and parking lot are open to the public. The contractor continues work on punch list items for the buildings, landscaping, irrigation, HVAC, lighting, electrical, and the sewer lift station.

Beachfront Improvement Feasibility Study Phase II – Findings and feedback obtained during the Option Development Phase of the study will be brought before the Parks and Recreation Commission on July 12 as an informational and discussion item.

Oceanside Housing Navigation Center / Shelter – Internal building demolition began the week of June 13 and is near completion. San Diego Rescue Mission is bidding out the remaining work. Staff are reviewing bids submitted for electrical, plumbing, and mechanical work.

Brooks Street ADA Project – The pre-construction meeting occurred on July 7. Construction surveying will be performed on July 14 and sidewalk construction is expected to begin on July 18.

Butler Street Storm Drain Lining Project – Construction began June 20, and is anticipated to be completed by the end of July.

Cleveland Storm Drain – City and California Coastal Commission (CCC) staff met on July 7 regarding the possibility of adding storm drain screens to catch basins throughout the design, as necessary. It is anticipated that this change will result in a positive CCC staff recommendation on the proposed project at a future CCC meeting.

Grandview Sidewalk In-Fill Project – The contract will be bid out this week. Staff continues working on acquiring the required easement.

WATER UTILITIES

2021 Annual Water Quality Report Now Available – The Annual Water Quality Report was published July 1 to provide customers with a summary of Oceanside drinking water quality for the previous calendar year. This includes water sources, a summary of samples collected throughout the year, as well as range of results, and specific information about water quality. We are proud to report that Oceanside's drinking water meets or exceeds all state and federal drinking water standards. The report is available now on the City website. CITY MANAGER'S OFFICE

Fire Station 1 Project – A groundbreaking ceremony will be held on Thursday, July 28 at 10:00 a.m. at the Fire Station 1 Project site at 602 Civic Center Drive. Refreshments will be served following a brief program in the courtyard, and a ceremonial "sledge hammering" of a portion of the current building. Funding from Measure X is supplying the project's major design and construction costs. Aside from Measure X, the City received a \$3.5 million federal Defense Community Infrastructure Program grant for this project -- one of only 13 projects selected nationwide.
