PLANNING

Downtown Advisory Committee – A Special Meeting is scheduled for Wednesday, December 13, at 9:00 a.m.

Planning Commission – The next Planning Commission meeting is scheduled for Monday, November 6, 2023 at 6:00 p.m.

ENGINEERING

Brooks Street Swim Center Renovations – The final deck concrete pours are expected this week. The contractor will then prepare the pool to be plastered and install the wading pool equipment, which is expected to take two weeks. Based on this, it is expected that the improvements will be complete by the end of November; however, the pool will not be re-opened until mid-December at the earliest to allow the plaster to cure.

Road Slurry Seal & Overlay Project – Work continued this week: ([Work Area Map](#)):

- ADA ramp demolition and reconstruction: The final push is on to complete the final group 4D Peacock Hill East (10 ramps remaining); completion expected November 10
- Final paving work resumes on November 20, and will continue through February 2024

Chavez Park Playground Replacement – A ribbon cutting ceremony was held at the park on Monday, October 30 to celebrate the improvements. The project is now complete except for punch list items and the potential addition of a surrounding fence.

PUBLIC WORKS

San Luis Rey River Flood Control Project Mowing 2023 - On October 25, the Public Works Department completed mowing of the Phase 1 & 2 sections (from Benet Rd. to College Blvd.) of the San Luis Rey River Flood Control Project. Later this month and into December, the US Army Corps of Engineers will start geotechnical investigations along the trail/access road. In addition, biological surveys will take place over the next two months as part of the large-scale invasive plant removal project to be completed in late 2024.
