COUNCIL WEEKLY UPDATE

February 5, 2021

PLANNING

Listed below are the Public Hearing items that the Planning Commission will review at its meeting on Monday, February 8, 2021:

ZENLEAF CANNABIS FACILITY- Consideration of two CONDITIONAL USE PERMITS (CUP19-00023 and CUP19-00024) to allow a cannabis cultivation and nursery facility with four greenhouses, totaling 87,230 square-feet, located at 5712 North River Road in the South Morro Hills Neighborhood Planning Area. The applicant is requesting a Waiver of Locational Criteria pursuant to Article 36, Section 3605 to allow a regulated use to be located closer than 1,000 feet from a residential zone district. **Staff is recommending approval.**

BROTHER BENNO'S REVIEW - Recommendations from the Brother Benno's Standing Committee regarding revisions to conditions of approval for the Brother Benno's Conditional Use Permit (C-33-90) to further regulate the operations of the Brother Benno's facility. The site is located at 3260 Production Avenue. **Staff is recommending approval.**

ENGINEERING

Street Overlay Project – The work associated with the various overlay locations, Rancho Hermosa, and Industry Street full depth reclamation areas is complete. Work for Mission Avenue between I-5 and Horne Street requires a Caltrans encroachment permit in order to commence construction, which was just obtained. Work is anticipated to start later this month.

PUBLIC WORKS

Alex Road Skatepark Update - The construction of the shade sails started this week at Alex Road Skatepark. Footings were prepared and steel poles are scheduled to be erected. The shade sail fabric installation is scheduled for next week.

WATER UTILITIES

Community Choice Energy (CCE) / Community Choice Aggregation (CCA) - Once contract documents are finalized, staff will begin work with a consulting firm to update the earlier 2019 CCE Feasibility Study. Work is anticipated to kick off in the coming weeks and this update effort will consider recent customer usage data, SDG&E rate changes, Power Charge Indifference Adjustment "exit fees" and resource adequacy charges. Once the work is complete, the findings will provide an updated perspective on the financial viability of moving forward with a CCE. In support of this effort, staff continues to explore partnerships with other regional agencies in the County. Staff has been in regular contact with sustainability staff at the County of San Diego, whose proposed governance model proposed an equal voice for partners, regardless of their size. The County Supervisors are anticipated to provide direction to staff during their meeting the first week of March, on whether to continue discussions with Oceanside or whether to discuss joining the City of San Diego CCE effort. The 78 Corridor cities will be contacted in the next two weeks on their CCE status and an update on those partnerships will be provided in February.

Pure Water Oceanside and Recycled Water Expansion Construction Update - Construction on Douglas Drive is expected to be complete by April 2021. The two-lane permanent closure with extended work hours on Douglas will be complete this week. Construction moving forward will include small service laterals, concrete work, and testing of the installed recycled water and Pure Water pipelines and will only require one lane closures during normal work hours. Paving of Douglas Drive is expected to occur in March and will require a full two-lane closure for a few days. Paving will be completed in full lane widths to provide a smooth even driving surface once completed. For areas where the pipeline was installed between two lanes, both lanes will be repaved. Installation of the recycled water pipeline on Pala Road is expected to begin next week and last for five weeks.

Development and testing is complete for one of the injection wells on Coco Palms. Sound walls will be removed this week around the completed injection well in preparation of construction of the below ground vault that will surround the well. The second injection well on Coco Palms will still be in development and testing for the next three weeks. Mobilization for the monitoring well at Fireside Park will begin this week, with drilling starting next week. Residents in the neighborhood received a mailer regarding the construction and where they can receive more information.

The Advanced Water Purification Facility (AWPF) continued construction with delivery and installation of the Reverse Osmosis (RO) Pumps and RO Skids (which feature membranes produced by Hydranautics, a local Oceanside company) and continued modifications in Plant 2. Next week, AWPF construction will continue with installation of roof trusses, additional foundation work, and Plant 2 process improvements. Residents who subscribe to construction updates received an e-newsletter in January which was also included in the City's February Oceanside Tide newsletter.

PUBLIC WORKS

J-Dock replacement project - The J-Dock replacement project is currently in the prefabrication stage as the new dock is being constructed in sections at the Bellingham plant in Dixon, California. Harbor Administration has worked diligently to place every slip renter on J-Dock with a temporary slip in the Harbor. This required matching vessel length, depth, width, tonnage and power requirements to a specific match at a temporary dock. The replacement project will be completed in two phases. During the 1st phase, two-thirds of the vessels will move to a temporary dock. Approximately two months later, the vessels from phase 1 will return to their permanent slip, while the remaining one third of the vessels move to a temporary slip. Construction on site is planned to begin mid-February and be completed by mid-May.
