PLANNING

Listed below are the public hearing items that the Planning Commission reviewed and took action on at its meeting on Monday, June 21, 2021.

1930 BROADWAY FOUR-PLEX – Consideration of a DEVELOPMENT PLAN (D20-00017) and REGULAR COASTAL PERMIT (RC20-00011), a request for approval to allow the demolition of an existing single-family residence in order to allow the construction of a new 3-story four-plex structure totaling 7,320 sq. ft. on a 6,098-sq. ft. parcel located mid-block at 1930 Broadway (APN:153-264-08). **The Commission adopted the resolution by a 7-0 vote approving the project. The call for review/appeal period ends on July 12, 2021.**

MELROSE DRIVE EXTENSION – Consideration of a GENERAL PLAN AMENDMENT (GPA21-00001) to remove from the City's Circulation Element an extension of Melrose Drive between North Santa Fe Drive and Spur Avenue. The proposed General Plan Amendment would amend text and map exhibits in the Circulation Element to remove reference to the extension of this segment of Melrose Drive. **The Commission on a 6-1 vote (Goodkind – No) to recommend the Melrose Extension not be deleted at this time and, instead, that its removal be evaluated as part of the on-going General Plan Update (Circulation Element).**

CITY MANAGER'S OFFICE

Request for Qualifications for Citywide Turnkey Energy Services - On June 22, staff released a Request for Qualifications from qualified firms with the ability and experience to provide assessment and turnkey design-build energy services. The City is seeking to partner with an entity that has demonstrated experience and capabilities to provide holistic, turnkey energy and water savings projects, renewable generation and energy storage projects, and ability to arrange for and/or self-finance projects. Submission of Statements of Qualifications are due on August 6. Staff will keep Council updated as we move forward with this project.

WATER UTILITIES

Land Outfall Alternatives Analysis RFP Update - The Land Outfall Alternatives Analysis Request for Proposals (RFP) was advertised on June 22, 2021. Consultants will submit their proposal in response to the RFP on July 26, 2021. This project will consider alternatives to repair the existing pipe, replace the pipe along the same alignment, and evaluate different alignment routes for approximately 3,500 linear feet of Oceanside Land Outfall to mitigate pipe defects. It is anticipated that Staff will recommend award of contract to the selected consultant at the September 15 City Council meeting.

Business Sustainability Workshop July 14, 2021 – Green Oceanside is working with the Oceanside Chamber of Commerce to host a Business Sustainability Webinar on Wednesday, July 14 from 10:00 -11:00 a.m. Businesses in attendance will learn how to incorporate economically-feasible sustainability measures into daily operations with resources from the Green Oceanside team and SDG&E.
