PLANNING

General Plan Update (GPU) Phase 2 – As June 20, more than 200 community members were registered for the <u>online community forum</u> taking place on Thursday, June 20 at 6 p.m. This does not include Spanish-speaking community members who choose to attend the in-person gathering at the Crown Heights Community Resource Center this evening, where translation services will be provided. Following this event, summaries of input received (in both English and Spanish) will be prepared and posted on the project website, <u>onwardoceanside.com</u>.

Cannabis Update – Staff held a kickoff meeting with the City's new cannabis consultant where expectations and next steps were discussed. The consultant has begun drafting evaluation criteria for reviewing local license applications and will conduct a fee study shortly to ensure full cost recovery for future application reviews and compliance audits.
