ENGINEERING

El Corazon Aquatics Center – Pool construction continues for the competition pool. Building work continues. Foundation work is nearing completion. Vertical construction is anticipated within the next few weeks. Site work is nearing completion.

ECONOMIC DEVELOPMENT

Following are statistics on the [City of Oceanside COVID-19 Business Loan program](#) as of June 10, 2020:

- Applications received: 29
- Total amount of loan funds requested: \$430,760
- Pending applications: 13 (missing one or more required documents; staff is working w/applicants to get complete loan packages)
- Applications denied: 1 (applicant did not meet eligibility requirements)
- Applications cancelled: 1 (applicant was not recommended for full loan by SBDC and preferred to cancel application vs. receive a lower amount)
- Applications currently under review by SBDC: 5
- Loan agreements awaiting applicant signature: 4
- Loans to be funded within 1-3 days: 1 (\$20,000)
- Loans funded: 3 totaling \$50,000
