CITY COUNCIL WEEKLY UPDATE September 28, 2017

City Manager's Office

San Diego County Hepatitis A outbreak - As of Saturday, September 23, the County's Health and Human Services Department has vaccinated 477 people (exclusively homeless and/or illicit drug using individuals in the high-risk population) within the City of Oceanside. As a reminder, the January Point in Time Count identified approximately 530 homeless individuals in the City. Vaccinations for First Responder and affected Library, Code Enforcement, Maintenance, Water, Housing & Parks and Recreation staff began on September 26. Staff vaccinations should all be completed no later than October 17 (most will be done sooner). The County advises that handwashing stations would be deployed in the next week. Public area sidewalk and lot cleaning continues on schedule. To date there have been no new cases of Hep A reported (beyond the initial 7 that the county notified us about two weeks ago) and no deaths attributed to Hepatitis A in Oceanside. City Attorney's Office

Helgren's Oceanside Sportfishing/Oceanside Sea Center - Staff has continued to coordinate with Helgren's and Oceanside Sea Center to find space in the Harbor to accommodate the operations of each group. To the extent these discussions impact Oceanside Adventures and the Coast Guard Auxiliary, they have been consulted, and there is general agreement among all parties regarding the premises to be occupied by each operation. Final lease terms are currently being negotiated, and staff plans to bring proposed written lease agreements with all affected parties to the Harbor Board for consideration at the November 1, 2017 meeting, prior to expiration of Helgren's existing lease on November 30, 2017.

Planning

Community meeting September 28 - The Planning Division will be hosting a community meeting on Thursday September 28 at 5:30 p.m. in the Council Chambers to explain proposed revisions to the City's Telecom Ordinance (Article 39) and receive public input. The draft revisions are intended to achieve compliance with State and Federal streamlining mandates and would result in ministerial approval for co-location facilities, administrative approval of a CUP for facilities involving new or revised camouflage and Planning Commission approval of non-camouflaged facilities in a residential zone.

Water Utilities

Downtown Water and sewer project update - Construction work as part of the Downtown Water and Sewer project will occur along Pier View in front of City Hall between Freeman Alley and Coast Hwy Alley next week, Monday – Wednesday, 10/2 -10/4, from 7 AM – 5 PM. Traffic control will be in place and parking in front of City Hall will be closed off. No parking signs will be posted in the area. The contractor, Burtech Pipeline, will be replacing an existing sewer line and manhole. No water will be impacted as part of this work. <u>MAP</u>

Community Choice Energy – In September 2017, the City of Encinitas sent an RFP for a Community Choice Energy (CCE) Technical Feasibility Study on behalf of the cities of Oceanside, Carlsbad, Encinitas and Del Mar (Partners). The Partners seek to understand the feasibility of CCE, including various options for development and implementation, as well as potential costs, risks, and benefits. It is the goal of the Partners to determine whether a CCE program(s) could be established for our communities that would meet the greenhouse gas emissions goals of the Partner cities while keeping electricity rates comparable to the local utility, San Diego Gas & Electric.

The Study will include the following items: (1) determine whether the cities of Oceanside, Carlsbad, Encinitas and Del Mar could reasonably expect to establish and operate a successful CCE program based upon a set of electricity supply scenarios; (2) determine to what extent the CCE program could offer renewable energy to residents and businesses and help achieve each city's greenhouse gas (GHG) reduction goals; (3) provide options as to how a CCE program could be structured, managed and successfully implemented; and (4) evaluate the potential risks and benefits associated with forming a CCE program, including the environmental, financial, economic, legal and technical implications. The study must provide adequate detail to inform the possible future preparation of a CCE Implementation Plan that could be certified by the California Public Utilities Commission. The deadline for submitting the proposals is October 6, 2017.
