CITY COUNCIL WEEKLY UPDATE

November 17, 2016

Planning

Listed below are the public hearing items that the Planning Commission will review at their meeting on Monday, November 21, 2016.

PUBLIC HEARINGS

OCEANSIDE ABBEY @ 695 BENET HILL ROAD — Consideration of a CONDITIONAL USE PERMIT (CUP15-00029) for the continued operation of an existing 80-foot high monopole tower hub facility with 25 antennas and multiple microwave dishes and site modification to replace 4 existing antennas with 4 new models, add 2 new Remote Radio Units (RRU) behind the replaced antenna and add 1 new DC-6 Surge Suppressor. **Staff is recommending City Council approval. This item has been continued to the December 19, 2016 Planning Commission meeting.**

1986, 1992 AND REDEVELOPMENT PROJECT AREA (DOWNTOWN D-DISTRICT) ZONING ORDINANCE CONSOLIDATION — Consideration of a LOCAL COASTAL PROGRAM AMENDMENT (LCPA16-00003) and ZONE AMENDMENT (ZA16-00006) to the City's 1986, 1992 and Redevelopment Project Area (aka Downtown D-District) Zoning Ordinances. The amendments involve repealing Articles 14.4, 35 and 36 of the 1986 Zoning Ordinance; modifying Articles 15, 16, and adding Articles 20 H-Harbor District to the 1992 Zoning Ordinance; and establishing the amended text for Articles 15, 16C, and 20 of the Zoning Ordinance and Municipal Code Chapter 30A-Special Event Permits, as part of the implementation plan of the Local Coastal Program. The primary focus of the proposed amendment is to: a) consolidate the 1986 Zoning Ordinance provisions for Open Space, Public Utility and Transportation Zone and Harbor Zone within the City's updated Zoning Ordinance; b) certify Zoning Ordinance Articles 15, 16C and 20; and Municipal Code Chapter 30A; and c) update references to decision-making bodies, City departments and management staff titles to reflect changes which have resulted from the elimination of the Redevelopment Agency and internal City reorganization. *Staff is recommending City Council approval.*

Water Utilities

Fixture Replacement Phase I - As part of the Water Department's ongoing efforts to reduce water use within the city, work will began this week to replace inefficient fixtures such as toilets, urinals at 20 city buildings and facilities. Once implemented, the project will reduce annual water use by 2.4 million gallons. City facilities scheduled for work include Fire Stations 1-7, Country Club and El Corazon Senior Centers, the Police Department, the Civic Center, Code

Enforcement and Library Buildings, the San Luis Rey Wastewater Treatment Plant, the Mission Basin Groundwater Purification Facility and the Brooks Street and Marshall Street pools. Staff will be notifying affected parties prior to construction. Construction will be completed by the end of 2016.

Recycled Water - Goat Hill is on schedule to start receiving recycled water upon passing their final walkthrough and testing requirements by the County Department of Environmental Health. Construction will be completed at El Corazon by November 21 at which time the Sports Complex will be able to receive recycled water once they pass the same walkthrough procedures and testing requirements.

The Water Utilities Department is currently advertising for statements of qualifications for design-build firms to construct a replacement for the existing recycled water treatment plant located at the San Luis Rey Water Reclamation Facility. The existing plant will be "at capacity" once the Goat Hill Golf Course and the Sports Complex at El Corazon begin using recycled water. The replacement plant will be able to produce up to 3 million gallons per day of high quality recycled water and will allow the City to expand the use of recycled water over the next 4 to 7 years. The recycled water treatment plant replacement project is scheduled to be operational by the summer of 2018.

Loma Alta Creek Emergency Sewer Replacement - The contractor, Arrieta Construction, has completed the majority of the new 18-inch sewer pipeline along Oceanside Boulevard and is currently constructing a 24 ft x 12 ft pit in preparation to drill under the Oceanside Blvd. and Rancho Del Oro intersection to the new 10-ft manhole already drilled inside the intersection. The contractor anticipates having traffic control set up along Oceanside Blvd. through the middle of December 2016. Work will then continue along Rancho Del Oro for the remainder of the contract. Groundwater is continually being encountered and continuously getting pumped out. The duration of the project has been pushed out approximately 30 days due to the extensive amount of groundwater and the existing working conditions. It is anticipated the contractor will be finished at the end of January 2017.

<u>Harbor</u>

Army Corps of Engineers Dredging Project – The dredging contractor CJW Construction (CJW) has concluded their dredging work and has been demobilizing, which CJW previously estimated to take one day, then five days; they are now at day sixteen.

The U.S. Army Corps of Engineers' survey vessel has completed the after-dredging survey which will determine the actual amount of sand dredged; we are waiting for the work-product from the Army Corps of Engineers showing the after-dredge condition of the Harbor Entrance area.

A walk-through of the beach areas where the dredge pipe was located with the Corps Staff has been completed.


Staff intends to send yet another letter to Colonel Gibbs and Congressman Issa, requesting that the Corps' contract with CJW be terminated and that the Corps' search for a different contractor that: 1) Will complete the job in 2017 by Memorial Day and 2) Has appropriately-sized equipment to expedite the work.

Public Works

Airport Landscape Project – All of the existing landscaping at the entrance of the airport has been removed and new irrigation and drought tolerant plants and trees are being installed over the next two weeks. The airport operator (APV) will maintain this area once the project is completed.

Army Corps of Engineers San Luis Rey River Sediment Removal Project - The project has been postponed until September 2017.

Municipal Pier Brace/Bracket Replacement Project - Ballard Marine will complete construction today and start removing the scaffolding which will take approximately two weeks.



Neighborhood Services

Section 8 Project-Based Veterans Affairs Supportive Housing (VASH) vouchers for Veterans - On November 14, 2016, the Oceanside Housing Authority was notified by the U.S. Department of Housing and Urban Development (HUD) that its application for 25 new Project-Based Section 8 VASH vouchers has been funded. With the addition of the new vouchers, the Housing Authority has been awarded a total of 110 veteran's housing vouchers since 2015. The project-based component of the program allows rental assistance to be attached to a specific unit and/or project instead of an eligible assisted household. The Housing Authority will initiate a proposal selection process and may select existing housing, new construction or rehabilitation projects. A target date for project selection must be submitted to HUD by April 14, 2017. The funding effective date is projected to be mid May 2017 and staff will bring a budget amendment to the City Council for acceptance of the award at that time.
