CITY COUNCIL WEEKLY UPDATE December 10, 2015

Planning

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on Monday, December 7, 2015.

PUBLIC HEARING ITEMS

MATLACH/CROSS RESIDENCE – Consideration of a REGULAR COASTAL PERMIT (RC14-00002) to allow the remodel of, and addition to, an existing single-family residence at 1709 South Pacific Street. *The Commission denied the project by a 7-0 vote. Resolution will be adopted at the December 21, 2015 PC meeting and the call for review/appeal period ends on December 31, 2015.*

CAMINO TOWN & COUNTRY REMODEL — Consideration of a TENTATIVE PARCEL MAP (P14-00011), DEVELOPMENT PLAN (D14-00017), and CONDITIONAL USE PERMIT (CUP15-00012) for the subdivision of 13.79-acre parcel into six commercial parcels and allow the demolition of approximately 84,305 square feet of commercial retail space and associated site improvements in order to enable the construction of 116,650 square feet of commercial retail space within four freestanding commercial buildings, a 10.8 percent reduction for required parking, and the addition of 7,500 square feet of commercial space to the existing southern portion of the larger Camino Town & Country Shopping Center located within the Fire Mountain Neighborhood. *The Commission approved the project by a 7-0 vote and adopted the resolution. The call for review/appeal period ends on December 17, 2015.*

ROBERTSON SUBDIVISION — Consideration of a TIME EXTENSION of a previously approved TENTATIVE PARCEL MAP (P-15-04), DEVELOPMENT PLAN (D-10-06), and two CONDITIONAL USE PERMITS (C-41-04, C-5-06) for a two-lot residential subdivision of an existing 0.71-acre property located at 228 Hoover Street. *The Commission approved the project by a 7-0 vote and adopted the resolution. The call for review/appeal period ends on December 17, 2015.*

DISCUSSION ITEM

Briefing on General Plan Update Memo of November 12th. *Item discussed.*

Development Services

Lot 23 Parking Structure - Development Services expects the construction plans for the Lot 23 parking structure to be submitted on 12/16 for plan check review.

Fed Ex Project - The project is expected to be completed from the exterior perspective by the end of 2015. The plans are in review for the interior portions and the package sorting system which is quite elaborate and will take several months to construct.

Public Works

San Luis Rey River Mowing Project: After 4 weeks, Washburn Grove Management has mowed approximately 86 acres. Mowing operations are currently west of the Benet Bridge and will be moving back towards the east for additional sections. Three pieces of equipment are currently on the project site.

El Niño Preparations: The San Luis Rey River Mowing Project should be completed prior to any major rain events, but the Army Corps of Engineers (ACOE) are also concerned with sediment deposits at the western end of the river reducing flow conveyance. Staff has prepared a Regional General Permit 63 for emergency work and will file with the ACOE at the appropriate time in order to carve channels in the deposits near the river mouth to redirect flow, increase flow capacity and decrease potential coastal flooding. Natural flow in the river may reduce the deposits and the permit will only be filed if necessary. Emergency work would start after initial rains and prior to a large storm event in accordance with state and federal regulations.

Police Department

Computer Aided Dispatch (CAD) System - The new police-specific Computer Aided Dispatch (CAD) system went live on December 8, 2015. The new system includes the most advanced TriTech Inform software with analytical and management search capabilities. The software will enable managers with the ability to assemble statistical information on demand. Police personnel now have a user friendly and faster response time mobile system, enabling staff to conduct investigations and prevent criminal activity while in the field by retrieving critical information from the new CAD system. The previous CAD system did not have the mobile data retrieval function. The CAD project was completed on time and under budget.
