Planning

Listed below are the public hearing items that the Planning Commission will review at their meeting on Monday, December 21, 2015.

CONSENT CALENDAR

MATLACH/CROSS RESIDENCE – Adoption of Planning Commission Resolution No. 2015-P37 denying a REGULAR COASTAL PERMIT (RC14-00002) to allow the remodel of, and addition to, an existing single-family residence at 1709 South Pacific Street.

TRANSPORTATION ITEMS

Request to establish permit parking on Foster Street and Saratoga Street per the Preferential Parking Permit Program. *Staff is recommending approval to City Council.*

PUBLIC HEARINGS

1909 S. MYERS STREET CONDOS – Consideration of a TENTATIVE SUBDIVISION MAP (T15-00001), DEVELOPMENT PLAN (D15-00001), and REGULAR COASTAL PERMIT (RC15-00002) involving the development of six, three-story residential condominium units in three duplex buildings on a 0.41-acre site located on the west side of S. Myers Street (1909 S. Myers) between Vista Way and Kelly Street. *Staff is recommending approval.*

302 S. FREEMAN — Consideration of a DEVELOPMENT PLAN (D14-00011) to memorialize an existing five-unit multi-family residential development on a 5,000-square-foot site. The property is located on the southeast corner of Michigan Street and Freeman Street at 302 S. Freeman. *Staff is recommending approval.*

THE VISTAS @ RANCHO DEL ORO VILLAGE XII "PACIFIC RIDGE" – Consideration of a TENTATIVE MAP (T14-00007) AND DEVELOPMENT PLAN (D14-00016) to allow the development of 314 dwelling units on 88 lots over a 28.2-acre parcel located in the Rancho Del Oro Master Plan Area, west of College Boulevard and north of Old Grove Road. **Staff is recommending approval.**

Development Services

Oceanside Beach Lofts Project - The Oceanside Beach Lofts project was submitted for plan check Monday. This is a mixed-use project with 10 residential units and ground floor commercial located at 314 N. Cleveland St.

Engineering

Annual Overlay - The City's contractor is in the process of obtaining railroad crossing permits from the North County Transit District. Upon securing the permits, we plan to pave El Camino Real between Fire Mountain Drive and Mesa Drive after Christmas.

Oceanside Boulevard Paving - The City is working on resolving pavement quality issues with the contractor. The road's smoothness will be accurately measured by engineering specialists. The contractor will be directed to remedy unevenness at the determined locations.
