# CITY COUNCIL WEEKLY UPDATE October 9, 2014

## **Planning Division**

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on Monday, October 6, 2014.

#### **Consent Item**

Construction of a vertical test production well (TW-2) within parking lot #10 at the terminus of Harbor Drive South near the outlet of the San Luis Rey River. The project site is located within the Coastal Zone, Oceanside Small Craft Harbor Precise Plan Area (Harbor Zone – H) and bears a "Harbor" General Plan and Local Coastal Plan land use designation. The Harbor zoning classification is a multiple-use category which accommodates boating and harbor-dependent uses, as well as coastal-related support services including public facilities. This proposal requires the review of the Planning Commission, and the approval of a Conditional Use Permit (CUP14-00023), Harbor Development Permit (D14-00014) and Regular Coastal Permit (RC14-00011) by the Harbor Board of Directors. *Item reviewed – The Commissioners voted 7-0* 

### **Public Hearings**

STRANDS END LLC @ 809 S. PACIFIC STREET – Consideration of a TENTATIVE TRACT MAP (T14-00001), DEVELOPMENT PLAN (D13-00012), and REGULAR COASTAL PERMIT (RC13-00016), a request for approval to allow the construction of two additional condominium units totaling 4,608 square feet on a new third floor of an existing four-unit condominium complex located at 809 South Pacific Street. *The Commission approved the project by a 7-0 vote and adopted the resolution. The call for review/appeal period ends on October 16, 2014.* 

FIRE MOUNTAIN INVESTMENTS LLC — Consideration of a TENTATIVE PARCEL MAP (P14-00004) and CONDITIONAL USE PERMIT (CUP14-00003), a request for approval to allow the subdivision of two existing legal lots totaling 1.39 acres into four new lots with a net lot area ranging from 11,619 sq. ft. to 14,006 sq. ft. in size. The project site is located at 1725 Avocado Road. *The Commission approved the project by a 7-0 vote and adopted the resolution. The call for review/appeal period ends on October 16, 2014.*

The new Starbucks Coffee at Town & Country Center has received Temporary Certificate of Occupancy approval on Monday, October 6.

#### **Public Works**

**San Luis Rey River Mowing** – Washburn Grove Management started mowing operations of the San Luis Rey River on October 1<sup>st</sup> and completed Phase III (11 acres) October 7. The contractor will begin mowing Phase I (24 acres) and Phase II (39 acres) on October 8 and anticipates this work will take approximately 2 weeks to complete.
