CITY COUNCIL WEEKLY UPDATE

Listed below are the public hearing items that the Planning Commission reviewed and took action at their meeting on Monday, June 24, 2013:

MOHSEN'S @ 628 S. COAST HWY - Consideration of a Regular Coastal Permit (RC13-00002) and Conditional Use Permit (CUP13-00007) to permit the conversion of an existing 1,350-square-foot vehicle service bay into a food market in association with an existing gas station located at 628 South Coast Highway. *This item was removed from the agenda and will be re-scheduled and re-noticed for a future public hearing date.*

HOUSING ELEMENT ACTION ITEMS: EMERGENCY SHELTERS AND TRANSITIONAL/ SUPPORTIVE HOUSING – Consideration of a Zone Amendment (ZA12-00008) and Local Coastal Program Amendment (LCPA 12-00003) to allow emergency shelters by-right within light industrial zoning districts outside of the Coastal Zone, incorporate state-prescribed definitions of transitional and supportive housing, and identify these two uses as permitted by-right in all residential zones, and establish portions of the amended text as part of the implementing document of the Local Coastal Program. The Commission approved staff recommendation by a 5-0 vote (Morrissey and Rosales – Absent). The Zone Amendment and Local Coastal Program is tentatively scheduled for City Council on August 21, 2013.

TRANSPORTATION ITEMS:

Request to restripe Via Rancho Road between Vista Alegria and Rancho del Oro Drive, and to establish a 5-minute Passenger Loading Zone on the north side of Via Rancho Road between Vista Alegria and Rancho del Oro Drive. *The Commission approved staff's recommendation by a 5-0 vote (Morrissey and Rosales – Absent).*

Request for all-way controls at the intersection of Kelly Street and South Horne Street. *The Commission denied staff's recommendation and approved the request for all-way controls at the intersection of Kelly Street and South Horne Street by a 4-1 vote (Troisi – NO and Morrissey and Rosales – Absent)*.

DISCUSSION ITEMS:

AT&T @ SF PEAK – Application for Substantial Conformity Determination (SC13-00017). *The Commission approved the substantial conformity by a 4-1 vote (Martinek* – *Abstain and Morrissey and Rosales – Absent) and adopt PC Resolution No.* 2013-P30 by a 4-1 vote (Martinek – Abstain and Morrissey and Rosales – *Absent). The call for review/appeal period ends on July 4, 2013.* SPRINT @ 805 COLLEGE BLVD. – CONDITIONAL USE PERMIT (CUP12-00019) to permit equipment upgrades and operation of an existing wireless communication facility at 805 College Boulevard. *The Commission repeal the June 10, 2013 PC action denying the project by a 4-1 vote (Balma – Abstain and Morrissey and Rosales – Absent) and adopt PC Resolution No. 2013-P28 by a 4-1 vote (Ross – NO and Morrissey and Rosales – Absent). The call for review/appeal period ends on July 4, 2013.*

SPRINT @ 551 SOUTH EL CAMINO REAL – CONDITIONAL USE PERMIT (CUP12-00026) to permit equipment upgrades and operation of an existing wireless communication facility at 551 South El Camino Real. *The Commission repealed the June 10, 2013 PC action, denying the project by a 4-1 vote (Balma – Abstain and Morrissey and Rosales – Absent) and adopt PC Resolution No. 2013-P29 by a 3-1-1 vote (Ross – NO, Balma – Abstain, and Morrissey and Rosales – Absent). The call for review/appeal period ends on July 4, 2013.*
