

## CITY COUNCIL WEEKLY UPDATE

July 18, 2013

### **Planning Division**

Listed below are the public hearing items that the Planning Commission will review at their meeting on Monday, July 22, 2013:

BUFFALO WILD WINGS – Consideration of a DEVELOPMENT PLAN (D13-00005), CONDITIONAL USE PERMIT (CUP13-00010) to allow the demolition of an existing and vacant restaurant building to allow the construction and operation of a new 6,003-square-foot Buffalo Wild Wings restaurant with an attached 1,002-square-foot outdoor patio on an approximately 0.38-acre site at the southwest intersection of El Camino Real and Vista Way within the El Camino North Shopping Center. *Staff is recommending approval.*

FITNESS TRAINING CENTER – Consideration of a CONDITIONAL USE PERMIT (CUP13-00016), a request to establish a fitness training center within an existing light industrial building located at 1832 Ord Way. *Staff is recommending approval.*

SPRINT @ 502 OCEANSIDE BOULEVARD – Consideration of a CONDITIONAL USE PERMIT (CUP12-00027) and REGULAR COASTAL PERMIT (RC13-00005), a request for approval to allow for equipment upgrades necessary to accommodate fourth generation wireless technologies and the continued operation of a wireless communication facility located at 502 Oceanside Boulevard. *Staff is recommending approval.*

SPRINT @ 1909 S. COAST HIGHWAY – Consideration of a CONDITIONAL USE PERMIT (CUP12-00029) and REGULAR COASTAL PERMIT (RC13-00006), a request for approval to allow for equipment upgrades necessary to accommodate 4G wireless technologies and the continued operation of a wireless communication facility located at 1909 S. Coast Highway. *Staff is recommending approval.*

SPRINT @ 3784 MISSION AVENUE – Consideration of a CONDITIONAL USE PERMIT (CUP12-00032), a request for approval to allow for equipment upgrades necessary to accommodate fourth generation wireless technologies (4G) and the continued operation of a wireless telecommunication facility located at 3784 Mission Avenue. *Staff is recommending approval.*

T-MOBILE @ 4039 AVENIDA DE LA PLATA – Consideration of a CONDITIONAL USE PERMITS (CUP12-00036) and CONDITIONAL USE PERMIT (CUP13-00023), a request for approval to allow for equipment upgrades and the continued operation of a wireless telecommunication facility located at 4039 Avenida de la Plata. *Staff is recommending approval.*

SPRINT @ 1680 OCEANSIDE BOULEVARD – Consideration of a CONDITIONAL USE PERMIT (CUP13-00005), a request for approval to allow for equipment upgrades necessary to accommodate 4G wireless technologies and the continued operation of a wireless communication facility located at 1680 Oceanside Boulevard. *Staff is recommending approval.*
