COUNCIL WEEKLY UPDATE

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on Monday, February 13, 2012:

<u>Pennant-Jones Addition</u> – Consideration of a Regular Coastal Permit (RC11-00007) to allow a 2,594-square foot addition to an existing single-family residence located at 2034 Lincoln Street. *The Commission approved the project by a 6-0 vote (Martinek – Absent) and adopted the resolution with addition of Engineering conditions. The call for review/appeal period ends on February 23, 2012.*

Sign Ordinance Local Coastal Program Amendment and Zone Text Amendment/Citywide Consideration of a Local Coastal Program Amendment (LCPA11-00002) and Zone Amendment (ZA11-00004) to the City's Sign Ordinances.

The Commission recommended approval of: a) amendments to the existing sign ordinance text to ensure regulation of signage in a constitutional manner; b) updates and clarifications of existing definitions; c) new regulations for digital display signage on private property; and d) a ban on "feather" signs. The Commission requested that language explicitly prohibiting commercial mascots on private property should be deleted and voted against the portion of the ordinance regarding digital display billboards on City owned property, as proposed. During the discussion, some Commissioners indicated a desire for more time and information to understand and vet billboard related issues. Further, the Commission advised that should billboard signage on City-owned property be approved, it should only be allowed as a trade/exchange of existing billboards at a ratio greater than 1 to 1. The Commission referred this matter to the City Council for final action. This issue will be presented to the City Council on March 28, 2012.
