

COUNCIL WEEKLY UPDATE

March 15, 2012

PLANNING DIVISION

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on Monday, March 12, 2012:

All Tune & Lube – Consideration of a Conditional Use Permit (CUP11-00027) to permit a vehicle repair and service facility known as All Tune & Lube within an existing commercial center located at 3965 Mission Avenue. ***The Commission approved the project by a 6-0 vote (Scrivener – Absent) and adopted the resolution. The call for review/appeal period ends on March 22, 2012.***

The Kolostyak Parcel Map – Consideration of a Tentative Parcel Map (P11-00001) and Conditional Use Permit (CUP11-00012) for a two-lot subdivision on a .52-acre parcel situated at the southeast of the intersection of Fire Mountain Drive and private road Victoria Lane within the Fire Mountain Neighborhood. ***The Commission approved the project by a 6-0 vote (Scrivener – Absent) and adopted the resolution. The call for review/appeal period ends on March 22, 2012.***

AT&T @ SF Peak – Consideration of a Conditional Use Permit (CUP10-00012). A request to allow new stand-alone wireless telecommunication facilities on a 10.42-acre City-owned property located at 3471 Cannon Road. ***The Commission adopted the MND by a 5-0 vote (Martinek – Recused), approved the project by a 5-0 vote (Martinek – Recused) and adopted the resolution. The call for review/appeal period ends on March 22, 2012.***

Lusardi Capistrano – Consideration of a Tentative Map (T-11-04), Development Plan (D-27-04), Regular Coastal Permit (RC-7-05), Conditional Use Permit (CUP-34-04), and Conditional Use Permit (CUP-3-09) to allow an 8-lot subdivision and development of eight single-family residences on an approximately 2.69-acre parcel. ***The Commission adopted the MND by a 5-1 vote (Martinek – No), approved the project by a 5-1 vote (Martinek – No) and adopted the resolution. The call for review/appeal period ends on March 22, 2012.***
