PLANNING DIVISION

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on Monday, May 7, 2012:

<u>Solar Gard</u> – Consideration of a Development Plan (D12-00007) and Conditional Use Permit (CUP11-00028) to allow the construction of a new 4,200-square-foot industrial warehouse building on a 2.94-acre site within the existing Prescott Industrial Park, and on-site storage of 13,000 gallons of Ethylene Glycol associated with the window film manufacturing process to be located at 1865 Ord Way. *The Commission approved the project by a 7-0 vote and adopted the resolution. The call for review/appeal period ends on May 17, 2012.*

Meritage Homes – Consideration of a Development Plan (D11-00015) to allow the construction of 92 new single-family detached dwellings on a 76.02-acre site in conjunction with limited revisions to the Architectural Guidelines for Hi-Hope Ranch. The property is zoned RE-B-SP-EQ (Residential Estate – B-Scenic Park-Equestrian Overlay), has a General Plan Land Use Designation of EBR (Estate-B-Residential), and is situated within the Guajome Neighborhood. *The Commission approved the project by a 7-0 vote and adopted the resolution. The call for review/appeal period ends on May 17, 2012.*

Staff previously informed the Council of the improvements that will be done at Women's Club Park located on Mission Avenue between San Diego Street and Brooks Street. Staff will convert all of the turf to drought-tolerant landscaping, mulch, and landscape rock. In order to receive a \$35,000 grant from the San Diego County Water Authority, the project must be substantially completed by June 1. Staff will start the project on Friday, May 11, by applying herbicide to kill the grass and removing several trees.
