## **PLANNING DIVISION**

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on Monday, June 11, 2012:

EL POLLO LOCO – Consideration of a DEVELOPMENT PLAN (D11-00006), CONDITIONAL USE PERMIT (CUP11-00010) and CONDITIONAL USE PERMIT (CUP12-00002) to allow the construction and operation of a new 2,734-square-foot El Pollo Loco restaurant with drive thru facilities at the southeast corner of College Boulevard and Plaza Drive. *The Commission approved the project by a 5-0 vote (Scrivener, Ross – Absent) and adopted the resolution. The call for review/appeal period ends on June 21, 2012.* 

MISSION SAN LUIS REY PARISH – Consideration of a DEVELOPMENT PLAN (D11-00009), CONDITIONAL USE PERMIT (CUP11-00014), VARIANCE (V12-00001), and HISTORIC PERMIT (H11-00002) to allow the development of a 57,361-square-foot combination sport court and parking lot on the northern portion of the MSLR Parish grounds. *This item has been continued to the July 23, 2012 Planning Commission public hearing.* 

<u>SINGH FARMS ACCESS REVISION</u> – Consideration of a DEVELOPMENT PLAN (D11-00008) to permit the construction of a new access road for an existing agriculture packing plant located north of Mission Ave/SR76 and east of Melrose Drive. *The Commission approved the project by a 5-0 vote (Scrivener, Ross – Absent) and adopted the resolution. The call for review/appeal period ends on June 21, 2012.* 

<u>APEX FIGHTING SPORTS</u> – Consideration of a CONDITIONAL USE PERMIT (CUP12-00013) and REGULAR COASTAL PERMIT (RC12-00011) to allow a Muay Thai, boxing, and martial arts fitness facility known as Apex Fighting Sports within an existing commercial building located at 215 South Coast Highway. *The Commission approved the project by a 5-0 vote (Scrivener, Ross – Absent) and adopted the resolution. The call for review/appeal period ends on June 21, 2012.* 

<u>SAYBROOK @ ARROWOOD</u> – Consideration of a DEVELOPMENT PLAN (D12-00008) to revise the architectural building types of 113 lots out of an approved 123-lot subdivision that was approved under original Development Plan (D11-00007). The 113 lots will be developed with a smaller building square footage than originally approved and will allow the option for single story developments. *The Commission approved the project by a 5-0 vote (Scrivener, Ross – Absent) and adopted the resolution. The call for review/appeal period ends on June 21, 2012.*
