COUNCIL WEEKLY UPDATE

PLANNING DIVISION

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on Monday, October 8, 2012:

ROADWAY AUTO TOWING – Consideration of a CONDITIONAL USE PERMIT (CUP12-00009) to establish a temporary auto tow yard on a portion of an existing developed site that is approximately 270,019 square feet in size and developed with a 29,225-square- foot single-story industrial building located at 1833 Oceanside Boulevard. The proposed auto tow yard would lease 24,436 square feet of the existing paved parking lot area for vehicle storage purposes and 754 square feet of the industrial building for office and vehicle retrieval purposes. *Item has been continued to the October 22, 2012, Planning Commission public hearing.*

KATES RESIDENCE – Consideration of a REGULAR COASTAL PERMIT (RC11-00012) to demolish an existing single-family residence and construct a new 2,355-square-foot single-family residence with a 471-square-foot garage on an 11,768-square-foot vacant lot located at 1909 South Pacific Street. *Item has been continued to the November 5, 2012, Planning Commission public hearing.*

BROWN RESIDENCE REMODEL – Consideration of a REGULAR COASTAL PERMIT (RC12-00014) to remodel and convert an existing single story duplex into a two-story singlefamily residence on an approximately 6,040-square-foot lot located at 1910-1912 South Pacific Street. *The Commission approved the project by a 5-0 vote (Scrivener, Martinek – Absent) and adopted the resolution. The call for review/appeal period ends on October 18, 2012.*

BURGESS/JOURNIGAN RESIDENCES – Consideration of a REGULAR COASTAL PERMIT (RC11-00002) to demolish two existing structures containing three residential units and construct a new three-story 6,424-square-foot structure containing two residential units at 1513 South Pacific Street. *Item has been continued to the October 22, 2012, Planning Commission public hearing.*

The Senior Transportation Program for City seniors continues to be a very popular program. During this past year, there have been 1436 Unduplicated Users; 3,577 Taxi Scrip Sold; 5,085 Shuttle Rides Provided; 16 Volunteer Drivers providing rides to 118 seniors needing transportation.
