Listed below are the public hearing items that the Planning Commission will review at their meeting on Monday, November 19, 2012:

STONE VAIL REMODEL REVISION – Consideration of a REGULAR COASTAL PERMIT (RC12-00017) for the revision of an existing coastal permit to remove conditions 16, 18, and 19. The Coastal Permit was approved by the Planning Commission on September 24, 2012, under resolution (2012-P45) to allow for the construction of an approximate 1,025 square feet of new floor area to an existing 3,230-square-foot home with a new total square footage of 4,255 square feet. The subject property is located at 30 Saint Malo. *Staff is recommending approval.*

BERGNA RESIDENCES – Consideration of a REGULAR COASTAL PERMIT (RC10-00013) and PARCEL MAP (P10-00005) to demolish two existing single-family dwellings and construct two new two-story single-family dwellings and establish via the parcel map two condominium units on a single lot at 1801 S. Meyers Street. **Staff is recommending approval.**
