

COUNCIL WEEKLY UPDATE

PLANNING DIVISION

Listed below are the public hearing items that the Planning Commission will review at their meeting on Monday, December 3, 2012:

WASTE MANAGEMENT CNG FUELING FACILITY – Consideration of a DEVELOPMENT PLAN (D11-00007), and CONDITIONAL USE PERMIT (CUP11-00013), a revision to an existing DEVELOPMENT PLAN (D-9-95), and CONDITIONAL USE PERMIT (C-24-95), for the installation of a compressed natural gas (CNG) fueling facility in order to allow the Waste Management of North County Trash Hauling Fleet to be converted from diesel fueled vehicles to cleaner CNG fueled vehicles. ***The meeting has been cancelled, this item has been continued to the January 14, 2013 Planning Commission meeting.***

NEIGHBORHOOD SERVICES

CALGRIP GRANT RECEIVED

The Board of State and Community Corrections has awarded the City of Oceanside a 2012-14 CalGRIP grant for \$500,000 through the Oceanside Police Department for gang suppression and prevention activities in the Eastside and Crown Heights neighborhoods. The grant application was a collaborative effort between Oceanside Police Department, the Neighborhood Services Department, Vista Community Clinic, and North County Lifeline. The Oceanside Community Safety Partnership Steering Committee is the coordinating and advisory council for this grant.

The grant funding period begins January 1, 2013, and runs through December 31, 2014. Grant programs include OPD suppression activities, and critical youth development / gang prevention programs in the Eastside and Crown Heights neighborhoods.

CalGRIP 2012-14 funds OPD officer overtime for approximately 82 directed patrol operations to reduce criminal activity committed by gang members, to compile and analyze information, and to update the current gang injunctions. Approximately 41 patrol operations are planned for each year of the grant. In addition to providing a high visibility in the identified neighborhoods and neighboring city parks, the officers will make contact with juveniles who appear to be engaging in at-risk behaviors, and will document the contacts. In order to increase the awareness of parents, officers will make home visits when they contact a youth with no history of gang involvement who is in the company of gang members or affiliates. Officers will contact any gang members encountered and make arrests when needed. Officers will be directed to conduct foot patrols in the neighborhoods, to contact citizens to gain community support for the increased police presence. Additionally, officers will conduct probation compliance checks when possible.

The CalGRIP grant also funds Vista Community Clinic's Project REACH youth program and associated services at the Joe Balderrama Recreation Center in the Eastside neighborhood, and North County Lifeline's Youth Development Program at the Crown Heights Resource Center for the 2-year grant period. Four Evidence Based Interventions

– Guiding Good Choices; Project Towards No Drug Abuse; ¡Cuídate! ; and Aggression Replacement Training are included in the program services to be provided by Vista Community Clinic and North County Lifeline. The required matching funds for the grant come from existing personnel and programs with OPD/Neighborhood Services, Vista Community Clinic, and North County Lifeline. There are no additional expenses incurred by the City for match.

CHRISTMAS TREE LIGHTING

Neighborhood Services and Oceanside Fire Department are once again partnering with Main Street Oceanside to provide this annual event. The Tree Lighting will take place at 6:00 p.m. on Thursday, November 29, 2012, in front of the Regal Cinema on Mission Avenue. There will be music and refreshments.
