Listed below are the public hearing items that the Planning Commission will review at their meeting on Monday, October 10, 2011:

New Birth Baptist Church – Consideration of a Conditional Use Permit (CUP11-00018) to permit a religious facility within an existing office building located at 2251 Mesa Drive (Item continued from the September 26, 2011 public hearing). ***Staff is recommending approval.***

Iravani Vehicle Storage – Consideration of a Conditional Use Permit (CUP11-00006) to allow for the temporary storage (2-4 days) of towed vehicles within an existing 8,000-sq. ft. structure, and certain associated site improvements, on the property located at 270 Via Del Norte. ***Staff is recommending approval.***

FINANCE/IT

On October 3, 2011, a newly updated utility bill was released to Oceanside utility customers through our outsourced provider as part of the streamlining enhancements outlined by the City Manager and approved by the City Council in June. The new bill features an easy-to-read billing summary as well as a comparison history chart. The bills are electronically generated internally and then transmitted to our outsourced provider which processes, prints, and distributes the bills via the U.S. Postal Service. This method reduces internal costs while providing a consistent level of service to our customers.
