Planning Commission

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on February 22, 2010:

Mission Ave. 76 Station Revision – Consideration of a Development Plan (D-2-08) and Conditional Use Permit Revision (C-17-84Rev08) to permit the construction of a 2,860-square foot mini-mart with restrooms and office located at 3361 Mission Avenue. ***The Commission approved the project by a 6-0 vote (Commissioner Bertheaud – absent) and adopted the resolution and the call for review/appeal period ends on March 4, 2010.***

Mimi's Café – Consideration of a Conditional Use Permit (CUP09-00014) to allow the sales of distilled spirits in association with an existing restaurant use known as Mimi's Café, located at 2177 Vista Way. ***The Commission approved the project by a 6-0 vote (Commissioner Bertheaud – absent) and adopted the resolution and the call for review/appeal period ends on March 4, 2010.***

Bank Transition from Bank of America to Union Bank

Beginning March 1 through April 30, 2010, the City will be transitioning from Bank of America to Union Bank. Council approved the new contract with Union Bank on December 16, 2009. The transition will begin with deposit services and credit card processing on March 1, 2010. Two new services related to revenue collection and deposits will commence on April 1, 2010. Lockbox (utility payment processing) and Remote Deposit (electronic transmission of deposits) will provide efficiencies and savings related to revenue collection. Disbursement services will also commence on April 1, beginning with Section 8 HAP payments. The first Accounts Payable run using Union Bank will be April 7 followed by the first Payroll run on April 9.

Unclaimed Funds Notice

In accordance with City Administrative Directive AD-29: Unclaimed Funds, a notice will be published in the North County Times on Friday, February 26, 2010, and Friday, March 5, 2010, listing outstanding checks three years or older. In order to claim the funds, a claim form must be submitted to the City Treasurer's office by April 19, 2010. The claim form is located on the City's Web site on the City Treasurer's Department

page. Any funds that have not been claimed by April 19 will be transferred to the City's General Fund. Unclaimed checks issued prior to January 31, 2007, total \$203,167.75. From this point forward, the Treasurer's Office will be publishing the unclaimed funds notices quarterly.
