COUNCIL WEEKLY UPDATE

February 15, 2008

Planning Commission Meeting

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on Monday, February 11, 2008:

<u>Sprint-Nextel Communications</u> -- For the construction and operation of a stand-alone communication facility consisting of 9-panel antennas and a 200-square-foot equipment enclosure located at 4700 Mesa Drive. The Commission approved the project by a 5-2 vote and adopted the resolution and the call for review/appeal period ends on February 21, 2008.

<u>Pacific View Medical Office</u> -- To construct a 39,835-square-foot medical office building and to allow surgery as part of a hospital land use on property located a 3300 Waring Road. The Commission approved the project by a 7-0 vote and adopted the resolution and the call for review/appeal period ends on February 21, 2008.

<u>Sandifer Variance</u> -- To allow the encroachment into the front yard requirement for the construction of a swimming pool located at 2329 Snead Drive. The Commission approved the project by a 7-0 vote and adopted the resolution and the call for review/appeal period ends on February 21, 2008.

<u>Newman Residence</u> -- To permit a residential structure to exceed the maximum height requirement located at 517 South Tremont Street. This item has been removed from the agenda and will be re-scheduled and re-notice for a future public hearing.

U. S. Department of Housing and Urban Development Review ranks City as "Good"

The City has received the draft Program Year 2006 Review Letter from the U.S. Department of Housing and Urban Development covering the City's use of Community Development Block Grant (CDBG), Emergency Shelter Grants and HOME Investment Partnership Program funds during FY 2006-07. The City received an overall assessment of "Good", which indicates that the City met or exceeded all programmatic and regulatory requirements. The report did note a need for improvement in support for Economic Opportunity. The Neighborhood Services Department is reviewing the report for possible comments; the final report will be issued after March 1, 2008.

Old Grove Road Opening

Chuck Knight, Vice President of J.T. Kruer & Co., Construction Management, recently notified the City that the section of Old Grove Road between Mesa Drive and College Boulevard is nearing completion and is scheduled for opening on Wednesday, February 20. Due to scheduling difficulties, there will be no ribbon-cutting for the opening.

Coast Highway Vision and Strategic Plan Update

Thirteen proposals were submitted to the City for consultant assistance for this effort. A staff committee has selected the top three respondents and invited these firms to make a presentation to staff of their proposal and approach. Staff expects to make a selection and will forward a recommendation for Council award of a contract in March 2008.

Center City Golf Course Alternation Study

The RFP for consultant assistance was issued on February 6, 2008, copies were sent to the City Council and it is posted on the City's Web site. Responses are due by March 6, 2008, and after staff review, Council award of a contract in expected in April 2008.

Oceanside Boulevard Vision Property Owner Facilitation

Staff received five proposals from firms responding to our RFP for the February 7, 2008, deadline. A staff team is reviewing the proposals and expects to have a recommendation for selection in March 2008. This property owner facilitation effort along the Oceanside Boulevard Corridor is a prelude to the formal master/specific planning effort that will begin later this year.

Save Our Streets

The next "Save Our Streets" community outreach activity will be on Saturday, February 23, from 11:00 a.m. to 3:00 p.m. at Cesar Chavez Park in Crown Heights. This will be a smaller neighborhood event and will include games for the children and outreach activities. OPD Neighborhood Policing Team members will be present.
