## **Planning Commission Meeting**

Listed below are the public hearing items that the Planning Commission reviewed and took action on at their meeting on Monday, October 20, 2008:

<u>Euro Institute of Skin Care</u> -- To allow a small scale personal improvement services in an existing commercial suite of the Plaza Mottino Shopping Center located at 4253 Oceanside Boulevard. The Commission approved the project by a 7-0 vote and adopted the resolution; call for review/appeal period ends on October 30, 2008.

<u>Fawcett Residence</u> -- To allow for the construction of a 5,320 square foot single family residence and reduced front yard setback from 40 feet to 30 feet located at 6221 Hidden Valley Road. The Commission approved the project by a 7-0 vote and adopted the resolution; call for review/appeal period ends on October 30, 2008.

Rancho Vista -- For remedial grading over a site area of 11.9-acres in order to provide geologic remediation and slope stability for an approved 29-unit (33-lot) single family subdivision on a larger 16.8-acre site located at the western terminus of San Dimas Drive, north of San Ramon Drive, and west of Rancho Del Oro Road. The Commission approved the project by a 5-2 vote and adopted the resolution; call for review/appeal period ends on October 30, 2008.

### First Residential Wind-to-energy Project

An Administrative Conditional Use Permit for the City's first residential wind-to-energy project, to be constructed at 4048 Echo Place (Rancho Del Oro neighborhood), is now in the public review/comment period. If no significant concerns are raised, the project may be administratively approved by the City Planner on October 24, 2008. The proposal calls for the installation and operation of a wind turbine consisting of a three-blade propeller, with each blade being three-feet long, which would be attached to a 33-foot tall aluminum pole. Control/conversion electronics would be attached to the existing single family residence. The proposed wind turbine will be located in the rear yard approximately 41 feet from any property line. # 2010 Decennial Census Local Update of Census (LUCA) Program

Since November 2007, the City of Oceanside's Planning Division has been working with the Census Bureau on improving and updating the address records for 2010 Decennial Census LUCA Program. By the use of the U. S. Census Bureau's Local Update Computer Program, the Planning staff was able to update the address records and add approximately 1,500 new addresses and developments to the LUCA system. By adding and updating the LUCA records, the U. S. Census Bureau is able to provide precise demographic data for all types of statistical analysis. Since the Planning staff provided

all the updated and added address information to the Census Bureau in a timely manner, the Planning Department was awarded a \$5,000 incentive check that is typically given to cities that perform all the 2010 LUCA updates.

## **CalHome Program**

The Neighborhood Services Department is pleased to announce that the State of California Department of Housing and Community Development has awarded the City of Oceanside \$900,000 in grant funds to continue to implement a first-time homebuyer program under the CalHome Program. The City of Oceanside has administered a successful CalHome first-time homebuyer program since 2002. The purpose of the CalHome Program is to provide funding to local public agencies for first-time homebuyer mortgage assistance for low-income households. Through the years, the funding for CalHome has come from bond funds approved by the voters of California. In November 2006, the voters approved Proposition 1C. The City of Oceanside has successfully applied for, and has been awarded, the maximum allocation of grant funds for each competitive funding round conducted under the CalHome Program. An important aspect of the CalHome Program is that every unit assisted through this Program counts towards the City of Oceanside's low-income housing goals. The Neighborhood Services Department will be presenting a staff report to the Community Development Commission on the December 17, 2008, agenda to accept these funds.

## **National Authors Day Program**

In celebration of National Authors Day, the North County Authors and Poets (NCAP) of San Diego will give writers the chance to connect with published authors and get tips on writing and publishing. A panel of publishers and published authors will address a variety of topics. This program will take place on November 1, from 10:00 a.m. to 3:00 p.m., in the Civic Center Library Community Rooms and will be filmed by KOCT for broadcast at a later date.

## **American Girls Tea Party**

Children ages 6-12 can celebrate the beloved book and doll series by dressing up and attending a lovely tea party in the Civic Center Library Community Rooms on November 8, at 11:30 a.m. Delicious refreshments and fine entertainment are sure to be a hit with youngsters and their favorite friends. Registration is needed for this free event, and can be done at any Oceanside Library location.

### **Housing Element Status**

The State Department of Housing and Community Development (HCD) has completed its review of the City's draft housing element. HCD has requested further revisions to address two specific areas.

- 1. HCD is requiring further analysis on actual governmental constraints upon the maintenance, improvement, and development of housing for all income levels and persons with disabilities. HCD wants a complete analysis on parking standards or to specifically amend parking standards for certain types of housing (e.g., studio and one-bedroom).
- 2. HCD is requiring that the City identify adequate sites which will be made available through appropriate zoning and development standards and with public services and facilities needed to facilitate and encourage the development of a variety of housing types for all income levels, including rental housing, factory-built housing, mobilehomes, and emergency shelters and transitional housing. HCD is requiring a parcel listing of sites with zoning to accommodate Oceanside's regional housing needs and a shortfall for 2,496 units for lower-income households. We are being asked to commit to rezone sufficient sites by a date certain to facilitate development. In addition, the City will need to amend zoning to permit emergency shelters within one year of adoption of the housing element.

Staff will continue to work with our consultant to address these last two items. Once the element has been revised to address these requirements, it will be in compliance with State Housing Element Law.

## **In-Lieu Fee Update**

The Ad-hoc committee, consisting of the Chairs of the Housing and Planning Commission, BIA representatives, affordable housing developers, and other interested stakeholders, is planning to reconvene on November 13, to continue discussions as to what formula should be used to determine the amount of the in-lieu fee. Due to the current housing market, the in-lieu fee would not be increased based on the current formula; in fact, it would likely go down slightly.

Once the Ad-hoc committee is prepared to make a recommendation, it will be forwarded to the Housing Commission and to the City Council for consideration.
